The MAIA program is one of the first graduate programs in the United Arab Emirates to prepare graduates for meaningful careers in international, governmental, and non-governmental institutions. MAIA courses provide students with specialized knowledge in international law and diplomacy, global governance and sustainability, and security studies while enhancing their skills in policy analysis. Students are trained to critically analyze global policies and propose alternative approaches to generate more efficient, effective, and sustainably outcomes.

Benefiting from the university's location in the heart of Dubai, students have the opportunity to engage with policymakers in a variety of international gatherings such as the World Government Summit, Dubai International Humanitarian Aid and Development (DIHAD), and the dozens of other international conferences that occur within the Emirates on an annual basis. A wide variety of relevant industries in both the public and private sectors further enhance the educational experience as students apply their skills to solve real-world challenges in internships and other applied activities.

At the core of the MAIA program is the belief that today's global challenges require investment in the next generation of analysts and policymakers. Accredited by the Southern Association of Colleges and Schools Commission on Colleges in the United States and the Commission for Academic Accreditation in the United Arab Emirates, the MAIA program empowers graduates to work in a range of institutions while contributing to a more stable, sustainable world. The Mission of the MAIA program is to prepare the next generation of policymakers to serve in national, regional, or local government agencies; international or non-governmental organizations; or multinational corporations while contributing to the advancement of Emirati and global society.

The MAIA program is a graduate-level, tencourse, 30 credit-hour program. It consists of four common core courses and six elective courses. Two of the common core courses provide broad exposure to the field of international relations and public policy. The third core course provides students with the necessary methodological skills to write their fourth core course, which is a Master thesis taken in the students' last semester. The remaining six courses are electives, and students have a choice to take two courses in each of the following three areas: International Law and Diplomacy, Global Governance and Sustainability, and Security Studies.

# WHY STUDY INTERNATIONAL AFFAIRS AT AUD?

The MAIA program at AUD was designed and is supported by faculty, who have extensive expertise and experience in academia, government, international organizations and NGOs. While they are all scholars in various disciplines, their teaching is shaped by strong ties to industry, whether through personal experience or active collaboration with professionals in the field.

This in turn enriches class discussions, as theories are applied to practical cases with lived experiences offering examples that further explicate material discussed. This is especially important in the MAIA program, which trains students to become tomorrow's policy makers and leaders.

In addition, MAIA helps students to develop competencies in research and scholarship while applying those skills to policy design, analysis and evaluation. While these are skills that are essential to those pursuing roles in the field of international affairs, they are also transferable skills, which can be applied to other settings – be it in private or public sector. As such, the MAIA program offers flexibility to graduates to pursue different roles in different sectors while cultivating competencies that will be invaluable no matter where they choose to work.

It goes without saying that Dubai's location makes studying MAIA at AUD even more attractive. Over the past few years, the UAE has offered a home to a variety of international and non-governmental organizations, whose numbers and kinds have been multiplying. As a result, various conferences and gatherings have been hosted annually in this metropolitan space bringing world class leaders from all around the globe to Dubai. As such, MAIA students have an opportunity to engage in the many conversations held in and around Dubai while also networking with potential future employers.



# WHAT CAN I DO WITH AN M.A. IN INTERNATIONAL AFFAIRS?

Because of the invaluable skills with which the MAIA program equips graduates, it opens doors to various careers. In fact, MAIA gives graduates the possibility to either stay on the same career path or to find new roles and influential positions as they progress from one achievement to the next. An M.A. in International Affairs can make the following possibilities a reality for students:

They can choose to join the diplomatic corps and represent their countries' interests around the world.

They can choose to become policy analysts who dive into a particular topic, country or region, analyzing and evaluating policies in different sectors – from government to media, international organizations to academia – while considering alternative policies and solutions to national, regional and global challenges.

They can choose to apply their competencies to consulting firms and private sector enterprises by adding an international outlook that identifies and highlights the interconnected nature of today's global issues – for example, linking trade to labor rights and sustainability.

In fact, there are a variety of areas in which MAIA graduates will be able to apply their skills. The following list overviews some of the many opportunities open to our graduates.



# RECOMMENDED COURSE SEQUENCING

Students must take MAIA 600 and MAIA 610 in their first term, as these are prerequisites for the electives, and they must take their Master Thesis in their final semester. Apart from these restrictions, there are no further sequencing requirements, and students can take any elective courses, as long as they ensure fulfilling two courses in each of the three elective areas. The sequencing of the electives below is a suggestion only and may be amended based on student interest.

## I COURSE LIST

The M.A. in International Affairs program will employ lectures, seminar discussions and presentations, and directed reading and research. Many of the courses will involve case studies, problem solving, and other active learning strategies. Below is a selection of some of the courses students will take during their MAIA journey:

#### MAIA 620 | International Policy Analysis

This course is a survey of major issues in designing, implementing and evaluating public policies in international relations. Theories and concepts from public policy will be applied to a variety of topics pertaining to the operations of states and international organizations with a view to understanding how policy is made and implemented.

# MAIA 650 | Environmental Governance and Sustainability

This course introduces students to the main actors and institutions involved in creating and addressing environmental issues at local, national and global levels.

Students will examine theoretical explanations and empirical findings to explore the roles that governments, markets and civil society play in managing environmental resources.

### MAIA 652 | Migration Governance and Humanitarianism

This course provides students with a critical framework with which to examine the global patterns of migration and humanitarian crises associated with them. The course introduces students to the core concepts, theories and scholarly debates about mass migration produced by political, economic and environmental disruptions. This course aims to challenge the students to examine the circumstances of vulnerable groups of political, economic and environmental migrants at risk, and design policy frameworks targeting institutional and social systems that assist and govern humanitarian situations at the local, national. regional and global levels.

#### MAIA 660 | Technology and Innovation for Sustainable Development

This course focuses on the complex nature of the relationship between technology, innovation, social change and sustainable systems. It examines the new technologies and technological innovation in the context of sustainable development, and investigates how contemporary technologies present challenges and opportunities for social, economic and environmental aspects of sustainable development.

#### MAIA 682 | Transnational Trafficking

This seminar introduces students to the multi-faceted issue of trafficking, from slavery and illegal arms sales to stolen art and cultural artifacts, narcotics, falsified medical products, and poaching in a global and comparative context. It also highlights the major problems that international organizations, governments, and grassroots actors must deal with when addressing and combatting transnational networks of production, smuggling, and buying and selling of human beings and contraband.

# MAIA 675 | War and Technology in the 21st Century


This chronologically organized seminar explores the influence of technology on warfare into the twenty-first century. Innovations in technology have been revolutionizing military affairs since human beings picked up sticks and rocks to fight each other. This has accelerated to a dizzving pace since the late nineteenth century, particularly with respect to industrial-era weapons and reconnaissance systems; communications, mobility and transportation capabilities; and new sources of energy, from nuclearpowered warships to electrically charged rail guns. This seminar brings students up to date in this field while training them to account for the role technology plays in military operations and warfare.



## ADVISORY BOARD

The MAIA program is in regular consultation with its distinguished Advisory Board members. Their active participation in and continuous support to the program have ensured that the MAIA curriculum addresses the needs of the industry in terms of competencies and skill sets. Board members played an important role in distilling the elective areas that MAIA focuses on, so that students get an education that draws on important thematic training while furnishing them with the appropriate methodological skills to analyze and formulate policies.

In addition to their advisory role, Board members have been invaluable in creating a link between the MAIA program and the broad international affairs community – from international organizations to NGOs, from consulting firms to governmental and academic institutions.





## **ADMISSIONS CHECKLIST**

- Undergraduate degree (bachelor's) with a minimum cumulative GPA of 3.00 (on a 4.00 scale) or better (or equivalent) earned from an institution accredited by the UAE Ministry of Higher Education and Scientific Research national or regional institutional accrediting body in the case of international applicants
- Graduation diploma
- Recognition of university certificate for international applicants to be obtained from UAE Ministry of Higher Education and Scientific Research
- Confirmation of university records (required from every university attended by the student before joining AUD)
- Test requirements:

Academic IELTS™ score of 6.5 or TOEFL® score of 550 ITP [Paper-based]\* or 79 IBT®

\*TOEFL ITP Paper-Based scores are accepted from approved centers in the UAE

- Statement of the applicant's career objectives
- CV/Resume (including two professional or educational references and their contact information)
- Passport copy and Emirates ID
- National military service letter (for UAE male nationals)
- AUD Health History Form
- Non-refundable application fee of AED 420

#### **Program-specific Admission Criteria**

- Applications for admission to the M.A. in International Affairs program will
  be evaluated by the Arts and Sciences Graduate Admissions Committee. This
  committee consists of the MAIA Program Director and two faculty members.
  The committee will employ a balanced approach, based on the principle that
  ample satisfaction by an applicant of one or more of the admission criteria
  may, to a reasonable extent, compensate for deficiencies in one or more of the
  other criteria used.
- In addition to university requirements for admission into graduate programs, an interview may be considered in admitting students to the M.A. in International Affairs program.
